

FOOTGOLF CLUBS GUIDELINES

FootGolf Club

There are two levels of FootGolf Clubs in the United States

Social FootGolf Clubs AFGL First Division Clubs



- Cost for Social Club Membership is \$100/year
- Pick a name for your Club. Make sure it is a unique name.
- Min. of 9 players.
- The Club President must have an active license with AFGL.
- Player licenses are not mandatory for players but moving them to obtain an Amateur License for ranking and leaderboard will be beneficial.

- Have a FootGolf course near you.
- Submit Club Logo for approval or ask the AFGL to help you create a logo
- Submit FootGolf Club membership form with registration fees.
- Create a Basic Website and/or Social Media page with contact information. You will have access to AFGL marketing material to help you promote your club.

At this point, AFGL will review your application, and you will receive an email when it has been processed.

- Cost for Club Membership is \$300/year
- You are required to be a Social Club in the previous season first.
- Min. of 12 players.
- All players need to hold an AFGL/FIFG World Tour License.
- Have an AFGL Course near you.
- Clubs are required to run at least 1

tournament the first year. These tournaments can be Pro/Am Tournaments in order to include Social Clubs and players with the Amateur License or guest players.

- Submit FootGolf Club Membership Form with a check of \$300.
- Participation in the U.S. National Club Championship each year.





Becoming a Sanction AFGL Club has the following benefits:

- Access to AFGL Umbrella for Marketing Material + Photo Gallery.
- Access to a network of FootGolf Courses across the United States.
- Cross promotion of your Club and AFGL, US FootGolf.
- Access to leadership and sponsorship opportunities on a national level as they become available.

- Access to BlueGolf for hosted tournaments.
- Right to be a part of Club National Meetings and Networking Opportunities.
- Be a part of the AFGL Club Network for regional Club competitions. (First Division Clubs only)
- Right to participate in AFGL Official
 Tournaments as a club and earn points for
 your Clubs ranking. (First Division Clubs only).
